

Bickford's Iced Coffee 99 not out promotion Terms & Conditions

How to Enter Details:

Consumers must purchase a Bickford's Iced Coffee syrup 550ml product during the Promotional Period from a Participating Outlet and either complete the entry form available from Participating Outlets or submit an online entry at www.bickfords.net/99notout. **Entries will be considered valid only when received through a Participating Outlet using an official entry form or via the Bickford's Australia website** . Entry is open to purchasers of Bickford's Iced Coffee 550ml at the nominated IGA and independent retail outlets only and is not available for purchases made through Coles or Woolworths stores. A maximum of two entries per person are permitted so long as each entry includes the completed entry form and separate receipt. The prize is a Cricket Cooler Esky valued at \$99.95. There are 99 Cricket Cooler Esky's to be won. Entrants must be over 18 to enter.

Terms & Conditions of Entry:

1. Information on how to enter and prizes forms part of these Conditions of Entry. All applicable laws and regulations apply.
