

The Bickford's Cordial Win \$20,000 Promotion Terms & Conditions

How to Enter Details:

Consumers must purchase any Bickford's 750ml Cordial product during the Promotional Period and complete the online competition entry form at www.bickfords.net/australiansummer or by mailing a completed in-store entry form (entry form available in selected stores only). **Entries will be considered valid only when received through the entry page on the Bickfords.net website or via the posted entry form.** Entry is open to purchasers of Bickford's 750ml Cordial at participating outlets in Australia. A maximum of two entries per person are permitted so long as each entry includes the completed entry form and separate receipt(s). Prize comprises a single prize of AUD \$20,000. Entrants must be over 18 to enter.

Terms & Conditions of Entry:

1. Information on how to enter and prize forms part of these Conditions of Entry. All applicable laws and regulations apply.
2. Entry is only open to residents of Australia aged 18 years and older. 5. The promotion begins at 9.00am ACDT on 1st November 2018 and closes at 11.59pm ACDT on Friday 11th January 2019 ("Promotional Period"). Winners will be notified on Monday 14th January 2019 and will have 10 days to claim their prize. Entries received after competition close on 11th January 2019 will not be included in the draw. The prize will be paid by electronic funds transfer to the winner's nominated bank account.
6. During the Promotional Period, the promotion will be conducted in retail stockists across Australia ("Participating Outlets") on the dates outlined in clause 5 and only while stocks last.

7. There is 1 major prize to be won as outlined in clause 8 of these Terms and Conditions which is valued at AUD \$20,000. The Promotion prize pool total is AUD **\$20,000**.
