### How to Enter Details:

Consumers must purchase two Bickford's® products (Juice, Cordial, Iced Coffee Syrups, Flavoured Dairy Alternative Drinks) during the Promotional Period from a Participating Outlet and submit an online entry at [www.bickfords.net/winagiftcard](http://www.bickfords.net/winagiftcard). **Entries will be considered valid only when received via the Bickford's Australia website.** Entry is open to purchasers of Bickford's products (Juice, Cordial, Iced Coffee Syrups, Flavoured Dairy Alternative Drinks) at nominated participating IGA and independent retail outlets only and is not available for purchases made through Coles or Woolworth stores. A maximum of three entries per person are permitted so long as each entry includes the completed online submission and separate receipt.
